Any changes that are not approved will be required to be reverted to the original approval or original state and condition before submitting the application.

**Owners must ensure vendors do not obstruct roadways or flow of traffic. All construction debris must be removed and picked up the same day promptly.**

**Section 1 - Paint** – You are required to submit a color from the current approved color book. No re-painting home same color, if the color is no longer an approved color scheme. You must list the colors on the form. No mixing and matching of scheme permitted. One complete color scheme must be selected from the book. Available via email. Flat exterior paint only to be used. All colors must be listed with their color number. (Example - Pure White – SW7005)

**Section 2 - Fences** - May only be wood or white or light tan vinyl only.

Waterfront properties must have non-obstructing fencing only in back yard.

Fences behind home that border the association brick wall must taper down the last 12 feet to meet the brick wall. No fences are permitted on top, next to, or above brick wall. Homes that are behind the brick wall can install white vinyl 4 feet from brick wall and add vegetation 2 feet from brick wall in front of vinyl fence. Guidelines are outlined in handbook. Covered structure fences for pumps, ac units, propane tanks or trash cans may be an L-shaped picket screening (Please refer to handbook), or a fence can be moved up in front to cover the structure, or vegetation can be planted in front to hide road visibility. All options require approval.

**Section 3 – Roof/Gutters (If doing at the time of roof or gutters only request)** – No shingles in the following shades of Red, Blue, or Green are permitted. **Gutters** – No colors of Black, Green, Red or Blue are permitted.

**Section 4 - Pavers and Driveway Extensions** – Pavers are permitted. Concrete is permitted. No mixing and matching of concrete and pavers are permitted. Must be all one or the other. No pavers in apron/sidewalk. Driveway extensions can only be 18” either side or 36” on one side only that leads to front walkway. Driveways may not extend over 19 feet wide. No added extension is permitted. Pavers may not be dark in color. Driveway aprons and sidewalks are not allowed to be done in pavers.

– May be 8x10x10 max size permitted. Sheds require Orange County Permit. Must be submitted for OC permit once HOA approves. Must meet building and zoning setbacks. Must be hidden with vegetation if visible from street view in any way. Must be in back yard only.

**Section 12 - Tree Pollarding /Tree Topping**

– This is not permitted without approval. If tree is pollarded without permission in some cases, you may be required to remove the tree and plant a new tree in its place.

– If replacing existing plants with like for like in plant beds this does not require review. Refreshing or adding mulch in plant beds does not require review. The install of rocks/stones, trees, bushes, new plants, plant bed curbing and pavers, and/or new upgrades to plant beds and yards require review. Removal of these items require approval as well.
